During the early years of our chapter, the need for a house was recognized, and, in 1911, the brothers moved into what has come to be known as "The Old House." In 1961, a more modern house was constructed around the old one. The dedication for our new house was held on October 29, 1961, during homecoming weekend. The new house is much larger and has more comfortable living conditions than our former one. Over the years, alumni support has allowed us to continue to improve the house. For example, in 1986, \$30,000 was spent on renovating our downstairs recreation room, which is not only one of the largest on campus but also the most attractive.

In preparation for our chapter centennial, we are in the process of making many house improvements. We renovated the party room in 1986, and we built the deck overlooking Beaver Avenue, repainted the entire house and upgraded the plumbing, all in 1989. Many other renovations have been planned for the near future, making our house the best it can be.
